This position will provide lead on the San Juan River Basin native fish conservation and management activities in New Mexico. The position provides primary responsibility for conducting field work and data analysis necessary to make informed management decisions to maintain or enhance the conservation status of native fish in the San Juan River Basin. The position will also participate in the San Juan River Basin Recovery Implementation Program. The position may also include responsibility for ancillary native fish projects outside the San Juan Basin, including but not limited to Zuni Bluehead Sucker. The position will provide supervision of a 6 month term technician position each year in support of native fish management activities. The position will be supervised by the Native Fish Program Manager and, when assigned, will temporarily report to biologists leading other aquatic resource projects in New Mexico.
